

SELF-GUIDED TRIP WAIVER

Please Read carefully. This affects your legal rights.

By virtue of purchasing tickets for and/or participating any trip and/or tour (the “Tour(s)”) offered by Kristen Kainrath and Charisse Crisci and in consideration for my being allowed to participate in the Tour(s), the receipt and sufficiency of which is hereby acknowledged, I, and if I am not yet 18 years old, my parent or legal guardian (individually and collectively referred to below in the first person singular) agree to be bound by each of the following provisions of this waiver, release of liability, indemnification, consent to medical attention and grant of rights (“Waiver”) with the knowledge that the Company will rely on same:

Voluntary Participation: I understand and confirm that my participation in the Tour(s) is voluntary. I am in good health and suffer from no physical or mental condition that would make me especially susceptible to injury or disability while participating in the Tour(s).

Comprehension of Risk: I fully comprehend and accept all of the risks associated with my participation in the Tour(s) including, without limitation, injury or death resulting from exposure to unfavorable weather conditions, food sickness, allergic reactions, choking, and injuries arising from self-inflicted accidents or mishaps, other participants, motor vehicles, and pedestrians. I understand that the Tour(s) take place in public venues under conditions largely beyond Company’s control.

Assumption of Risk: I assume all risks, known and unknown, foreseeable and unforeseeable, in any way connected with my participation in the Tour(s). I accept personal responsibility for any liability, injury, loss, or damage in any way connected with my participation in the Tour(s).

Release of Liability: Limitation of Damages. I hereby forever and unconditionally release Company and its affiliated entities, parent companies, subsidiaries, present and former employees, owners, officers, members, managers, partners, contractors, insurers, shareholders, and directors (collectively “Released Entities”), from any and all claims, actions, damages, liabilities, losses, costs, and expenses (including, without limitation, attorney’s fees) for death, injury, loss or damage of property, (collectively “Claims”) in any way arising out of my participation in the Tour(s), including, without limitation, any and all Claims resulting from the negligence of the Released Entities. Company’s liability to me will be limited to actual damages arising from Released Entities’ gross negligence or willful misconduct in the performance of their duties and responsibilities hereunder; provided, however, under no circumstance shall my damages in connection with my participation in the Tour(s) be greater than \$500. Recovery of such amount shall be my sole and exclusive remedy. All liability arising out of my participation in the Tour(s) is cumulative and not per incident. In no event shall Company be liable for any

special, incidental, punitive, or consequential damages or other indirect damages, even if Company has been informed of the possibility thereof.

Indemnification: I agree to defend and indemnify the Released Entities from any and all Claims as incurred of any kind whatsoever in any way arising out of my participation in the Tour(s).

Binding Effect: This Waiver shall be binding upon my next of kin, personal representatives, heirs, beneficiaries, and assigns and shall insure to the benefit of Company, its successors and assigns.

Consent to Medical Treatment: I authorize hosts to provide to me, through medical personnel of its choice, customary medical assistance, transportation, and emergency medical services. This consent does not impose a duty upon the hosts to provide such assistance, transportation, or services.

Severability: If any provision of this Waiver is for any reason declared to be invalid or unenforceable, the validity and enforceability of the remaining provisions will not be affected. The invalid or unenforceable provision will be deemed modified to the extent necessary to render it valid and enforceable, and if no modification may render it valid and enforceable, this Waiver will be construed as if not containing such provision and the rights and obligations of the parties will be construed and enforced accordingly.

Governing Law and Venue: This Waiver shall be governed in all respects by the laws of the State of Illinois without regard to conflict of law principles. Venue shall be in DuPage County, Illinois.

Promotional Release: I hereby grant to Company the unrestricted right and permission to copyright and use photographic portraits, pictures, video footage and/or audio recordings of my participation in the Tour(s), in which I may be included intact or in part, including the negatives, prints, transparencies or digital information relevant to such portraits (the "Material"). Company has the right to reproduce, exhibit, distribute, broadcast, digitize, edit, or otherwise use the Material, by any method and in any media, whether now existing or later created, without restriction throughout the world, by incorporating the Material into its website, publications, catalogues, brochures, books, magazines, social media or commercial, informational, educational, advertising, or promotional materials relating thereto (collectively, the "Works"). I agree that Company is and shall be the exclusive owner of all right, title, and interest, including copyright, in the Material and the Works. I further grant to Company an irrevocable, royalty-free, worldwide license to use my name, age, and hometown in connection with the Material and the Works.

THIS IS A WAIVER AND RELEASE OF LIABILITY. I HAVE READ THIS ENTIRE DOCUMENT. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO ITS PROVISIONS. BY CONTINUING TO PARTICIPATE IN THE TOUR(S), I AM INDICATING MY VOLUNTARY AGREEMENT TO THE PROVISIONS OF THIS WAIVER AND RELEASE OF LIABILITY.

PARTICIPATION IN THE TOUR(S) BY A PERSON WHO IS NOT YET 18 YEARS OLD INDICATES THAT A PARENT OR LEGAL GUARDIAN HAS ALSO READ AND CONSENTED TO THIS WAIVER.

We are not responsible for changes in air itineraries or flight times and does not provide advice or alerts regarding air travel tickets, flight status or delays.

TRAVEL DOCUMENTS: It is your responsibility to obtain information and to have in your possession all the required documentation and identification required for entry, departure and travel to each country or region. This includes a valid passport and all travel documents required by the relevant governmental authorities including all visas, permits and certificates (including but not limited to vaccination or medical certificates) and insurance policies. You must have a passport that is valid 6 months after the last date of travel with us as set out on your itinerary.

You accept full responsibility for obtaining all such documents, visas and permits prior to the start of the Tour, and you are solely responsible for the full amount of costs incurred as a result of missing or defective documentation.

MEDICAL REQUIREMENTS & PROGRAM SUITABILITY: You must provide the required Medical Suitability Form, within 14 days of your enrollment. Medical Forms are mandatory for every participant, every Trip. Participants are responsible for specifically notifying us by email or phone if the participant has any pre-existing medical conditions which may impact their ability to travel, participate in an activity, travel to remote areas without access to medical facilities or may adversely affect the experience of others on the Trip.

You agree to complete the Medical Form honestly and to disclose all relevant medical information accurately and fully. Parent(s)/guardian(s) are responsible for assessing whether a program is suitable for your child or ward.

You should consult the participant's physician and/or your local travel clinic to confirm your fitness for travel and participation in any planned activities. You should seek your physician's advice on vaccinations and medical precautions. We do not provide medical advice. It is your responsibility to assess the risks

and requirements of each aspect of the program based on your child or ward's unique circumstances, limitations, fitness level and medical requirements. Travel may involve visiting remote or developing regions, where medical care may not be easily accessible and medical facilities may not meet

the standards of those found in your home country. The condition of medical facilities in the countries

visited makes no representations and gives no warranties in relation to the availability or standard of medical facilities in those regions. We reserves the right to deny you permission to travel

or participate in any program at any time and at your own risk and expense which determines that your physical or mental condition renders you unfit for travel or you represent a danger

to yourself or others. Parent/guardians understand that they are required to have medical insurance for the participant and are solely responsible for covering any and all of participant's medical costs and expenses.

SPECIAL REQUIREMENTS: Any special requirements must be disclosed to us at the time of booking. We will use reasonable efforts to accommodate special requirements or requests but this is not always possible given the nature of the destinations visited and availability of options outside a planned itinerary.

Certain activities may be inaccessible to you if your mobility is limited in any way. All food allergies and

dietary restrictions must be disclosed to us at the time of booking but we cannot guarantee that dietary needs or restrictions can be accommodated. Any special requests or requirements do not form part of these Terms or the contract between you and us and we are not liable for any failure to accommodate or fulfil such requests.

ASSUMPTION OF THE RISK: Participant and his/her parent or guardian understand that educational, instructional, recreational and/or adventure activities include inherent and other risks, hazards and dangers that can cause injury, death or other loss. Trips include a wide range of activities. Activities take place in remote geographic locations, several hours from medical facilities, causing potential delays in communication, transportation, evacuation and medical care. Although staff or contractors may have wireless devices (including cell phones) while conducting programs, use of these devices in international, outdoor, mountainous and/or wilderness terrain is unreliable and inconsistent. Participant agrees that representatives are and have been available to answer any questions about these activities and the associated risks, and that participant is voluntarily participating in activities with knowledge of the risks. Participant and parent/guardian agree to accept and assume all inherent and other risk arising from or related to activities, including any injury or other loss resulting from those risks. Neither us nor its officers, directors, contractors, employees, agents or staff can safeguard against injuries or accidents which may occur for whatever reason on any program.
